"A RESOLUTION APPROVING SPECIAL EDUCATION FUND (SEF) SUPPLEMENTAL BUDGET NO. 1 FOR THE CALENDAR YEAR 2021 OF THE PROVINCE OF DAVAO DE ORO AMOUNTING TO ELEVEN MILLION FIVE HUNDRED FIFTY SIX THOUSAND NINE HUNDRED TWENTY PESOS AND 61/100(P11,556,920.61) ONLY FOR PRIORITY EDUCATION PROGRAMS, PROJECTS AND ACTIVITIES IN THE PROVINCE."

WHEREAS, Ms. Grace V. Quintana, Acting Provincial Treasurer presented to the body the the cash availability available for operations under Special Education Fund (SEF) amounting to Eleven Million Five Hundred Fifty Six Thousand Nine Hundred Twenty Pesos and 61/100 (P11,556,920.61);
