"A RESOLUTION APPROVING SPECIAL EDUCATION FUND (SEF) SUPPLEMENTAL BUDGET NO. 2 FOR THE CALENDAR YEAR 2022 OF THE PROVINCE OF DAVAO DE ORO AMOUNTING TO SIX MILLION FIFTY-SEVEN THOUSAND SIX HUNDRED SEVENTY TWO PESOS AND 11/100 (P6,057,672.11) ONLY FOR PRIORITY EDUCATION PROGRAMS, PROJECTS AND ACTIVITIES IN THE PROVINCE."
