

WHEREAS, letter-dated December 15, 2022 of the Provincial Governor, Hon. Dorothy P. Montejo- Gonzaga, addressed to the members of the Sangguniang Panlalawigan, through the Hon. Jayvee Tyron L. Uy, MPA, vice governor, this province, forwarding the Supplemental Budget No. 05 for calendar year 2022 involving the amount of One Hundred Ten Million Three Hundred Seventy-One Thousand Pesos (P 110,371,000.00) from the General Fund, for review and appropriate legislative action;
