WHEREAS, Ms. Eva Jean S. Licayan presented the Source of Funds and the corresponding appropriation for the Supplemental Budget No. 1 - CY 2023 amounting to Five Million Six Hundred Seventy Six Thousand Three Hundred Forty Two Pesos and $48/100 \ (P5,676,342.48)$;


