**WHEREAS**, on June 10, 2024, the office of the Secretary to the Sanggunian received the letter from the Provincial Treasurer, Ms. Grace Quintana, addressed to the Honorable Vice Governor/Presiding Officer, Hon. Jayvee Tyron L. Uy, MPA, requesting for a passage of an Appropriation Ordinance adjusting the Local Economic Enterprise (LEE) Fund for CY 2024 Annual Budget of the Province pursuant to the review of the Department of Budget and Management (DBM) was presented in the plenary, for appropriate legislative action;

**WHEREAS**, in view of its urgency as certified by the Governor, the same was tackled in the plenary under the Committee of the Whole;

**WHEREAS**, pursuant to the provisions of the Local Government Code of 1991, the DBM's review of the CY 2024 Annual Budget (AB) of the Province of Davao de Oro, involving the appropriation amounting to P2,334,314,970.00 for the General Fund and P545,672,500.00 for the Economic Enterprise under Appropriation Ordinance (AO) No. 01-2024, submitted to the DBM for review on March 27, 2024, reveals substantial compliance with the same law and its implementing rules and regulations;

**WHEREAS**, as stated in the review of the DBM, there is an Excess Appropriation amounting to P 2,984,195.00 for the Local Economic Enterprise as a result of the reenactment of the previous year's appropriation and after adjustments in the Income Estimates and Total Appropriation in the LEE Fund;

**WHEREAS**, Section 323 of RA 7160 or the Local Government Code of 1991 states that in case the revised income estimates be less than the aggregate reenacted appropriations, the local treasurer concerned shall accordingly advise the sanggunian concerned which shall, within ten (10) days from the receipt of such advice, make the necessary adjustments or reductions. The revised appropriations authorized by the sanggunian concerned shall be the basis for disbursements;

**WHEREFORE**, the Sangguniang Panlalawigan enacted Appropriation Ordinance No. 02, adjusting the Appropriation of the Local Economic Enterprise (LEE) Fund for CY 2024 in the Amount of Two Million Nine Hundred Eighty Four Thousand One Hundred Ninety Five Pesos (Php2,984,195.00) to be Deducted from the Provincial Economic Enterprise and Management Office-Miscellaneous Personnel Benefits Fund (PEEMO-MPBF) of the 2024 Annual Budget of the Province of Davao de Oro;

Be it ordained by the Sangguniang Panlalawigan of Davao De Oro, in session assembled that:

**Section 1.** The reenactment of the previous year's appropriation under the Local Economic Enterprise (LEE) would result in an Excess Appropriation amounting to P2,984,195.00 after adjustments in the Estimates of Income and Total Appropriation in the LEE Fund, to wit:

**Section 2.** The budget approved in the 2024 Annual Budget for the Provincial Economic Enterprise Management Office-Miscellaneous Personnel Benefits Fund (PEEMO-MPBF) is Twenty Million Nine Thousand Seven Hundred Twenty-Five Pesos (P 20,009,725.00).

**Section 3.** The Excess Appropriation amounting to P 2,984,195.00 for the Local Economic Enterprise shall be deducted from PEEMO-MPBF as shown below:




