WHEREAS, letter-received August 14, 2024 of the Provincial Governor, Hon. Dorothy P. Montejo-Gonzaga, addressed to the Members of the Sangguniang Panlalawigan, through Hon. Jayvee Tyron L. Uy, MPA, Vice Governor, this province, requesting for a passage of an Appropriation Ordinance further reducing the Local Economic Enterprise (LEE) Fund for CY 2024 Annual Budget of the Province pursuant to the review of the Department of Budget and Management (DBM) was presented in the plenary, for appropriate legislative action;

WHEREAS, in view of its urgency as certified by the Governor, the same was tackled in the plenary under the Committee of the Whole;

WHEREAS, pertaining the review of the Department of Budget and Management (DBM)- Regional Office (RO) XI dated August 09, 2024 of the CY 2024 Supplemental Budget No. 1 of the Province of Davao de Oro, involving an appropriation of P61,171,833.00 for the Local Economic Enterprise as embodied in the Appropriation Ordinance (AO) No. 03-2024, they have found additional items in the CY 2023 Supplemental Budget Nos. 2 and 3, for Medical, Dental. Laboratory Supplies (MDLS) Expense account amounting to P5,620,000.00 that should form part of the reenacted items in the CY 2024 Annual Budget, following its review letter dated June 7, 2024;

WHEREAS, in this case, the total reenacted amount for the said account should be P52,168,195.00 instead of P46,548,195.00, which resulted to a total excess appropriation of P8,568,195.00;

WHEREAS, while AO No. 2-2024 was enacted to adjust/reduce the Miscellaneous Personnel Benefits Fund (MPBF) of the PEEMO amounting to P2,984,195.00, the DBM RO XI further advised for an adjustment amounting to P5,584,000.00;

WHEREAS, in a nominal voting called by the Presiding Officer, ten (10) members voted in favor of the approval of the budget, namely Honorable Members Apsay, Rañon, Basañes, Caballero, Jayectin, Mabanglo, Lopez, Ang, Secuya and Arancon.

WHEREFORE, the Sangguniang Panlalawigan enacted Appropriation Ordinance No. 04, further reducing the Appropriation of the Local Economic Enterprise (LEE) Fund for CY 2024 in the Amount of Five Million Five Hundred Eighty-Four Thousand Pesos (Php5,584,000.00) to be deducted from the Provincial Economic Enterprise and Management Office-Miscellaneous Personnel Benefits Fund (PEEMO-MPBF) of the 2024 Annual Budget of the Province of Davao de Oro;






