- 2.) DTI/SEC
- 3.) Mayor's Permit
- 4.) Tax Clearance
- 5.) Audited Financial Statement
- 6.) Net Financial Contracting Capacity (NFCC)
- 7.) Omnibus Sworn Statement

Failure to comply any of the above conditions, The Bid Security shall be forfeited and appropriate sanctions and existing laws shall be imposed.

Finally, Section 40.2 in the case of the failure, refusal or inability of the bidder with LCRB or HRRB to submit the documents required under Section 37.1 of this IRR or to enter into contract and post the required Performance Security, as provided in this Section, the BAC shall disqualify the said bidder, and shall initiate and complete the post-qualification process on the bidder with the second Lowest CalculatedB Bid/Highest Rated Bid: this process shall be repeated until the LCRB or HRRB is determined for award. However, if no bidder passes post - qualification, the BAC shall declare the bidding failure and conduct a re - bidding with re - advertisement. Should there occur another failure of bidding after the conduct of the contract's re - bidding, the Procuring Entity concerned may enter into a negotiated procurement.
