"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-1755 TO DAVAO TCM HARDWARE AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF CONTAINER VAN CLASS B, 20 FTR PAINTED, WITH PLY-BOARD FLOORING UNDER BID NO. B-24-0132 REBID,"

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF CONTAINER VAN CLASS B, 20 FTR PAINTED. WITH PLY-BOARD FLOORING under Bid No. B-24-0132 REBID POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;
