"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-2560 TO STARGLASS TEMP & SIGNAGE PROFESSIONALS AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND INSTALLATION OF GLASS UNDER BID NO. B-24-0142."
