"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-C1390 TO GOODWILL GENERAL MERCHANDISE AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES UNDER BID NO. B-24-0163."
