# **RESOLUTION NO. B-2024.11.20.04**

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3219 TO HYUNDAI SOUTHERN MINDANAO INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF LIVESTOCK VEHICLE (BRAND NEW) UNDER BID NO. B-24-0187."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of Supply and Delivery of Livestock Vehicle (Brand New) under Bid No. B-24-0187 POSTED in its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

**WHEREAS**, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on July 16, 2024, that were attended by the following bidders/suppliers, to wit;

WHEREAS, the Committee agreed that EDWIN S. SANTIAGO ENTERPRISES CORPORATION shall undergo post-qualification by the Technical Working Group for being the lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on July 31, 2024, resulted in the following;

WHEREAS, after a thorough examination, validation, and verification of the eligibility, technical, and financial requirements, it was determined that **EDWIN S. SANTIAGO ENTERPRISES CORPORATION** was non-responsive due to its failure to comply with the requirement for an After-Sales Service Center within the Davao Region, as stipulated in the Technical Specifications;

WHEREAS, the BAC further agreed that in the event that the bidder with the Lowest Calculated and Responsive Bidder (LCRB) fails, refuses, or is unable to submit the necessary documents as stated in Section 37 of this IRR, the BAC will disqualify said bidder and proceed to complete the post-qualification process with the bidder having the second Lowest Calculated Bid. If no bidder successfully passes the post-qualification stage, the BAC will declare the bidding as a failure and arrange for a re-bidding with readvertisement. If another bidding failure occurs even after the contract's re-bidding, the Procuring Entity is permitted to engage in a negotiated procurement.

WHEREAS, the Lowest Calculated Bidder was formally notified in writing of its post-disqualification and the grounds thereof; and with no motion for reconsideration submitted within the prescribed period, the Committee resolved to proceed with the post-qualification evaluation of IMAGE DAVAO MOTORS PHILIPPINES, INC., as the second lowest bidder, to assess whether the bidder complies with and is responsive to all the requirements and conditions outlined in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on September 25, 2024, resulted in the following;

WHEREAS, upon thorough examination, validation, and verification of the eligibility, technical, and financial requirements, it was determined that IMAGE DAVAO MOTORS PHILIPPINES, INC. was non-responsive due to discrepancies in the overall length and wheelbase of the offered unit, which did not conform to the required specifications;

WHEREAS, the Second Lowest Calculated Bidder was formally notified in writing of its post-disqualification and the grounds thereof; and with no motion for reconsideration submitted within the prescribed period, the Committee resolved to proceed with the post-qualification evaluation of HYUNDAI SOUTHERN MINDANAO INC., as the third lowest bidder, to assess whether the bidder complies with and is responsive to all the requirements and conditions outlined in the bidding documents;

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical and financial requirements, **HYUNDAI SOUTHERN MINDANAO INC.** has been found to be the Lowest Calculated and Responsive Bidder;

WHEREAS, the detailed evaluation of bids conducted on September 25, 2024, resulted in the following;
