"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3220 TO FRONTIER AUTOMOTIVE MARILAO CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF MINI DUMPTRUCK (BRAND NEW) UNDER BID NO. B-24-0188 Rebid."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF MINI DUMPTRUCK (BRAND NEW) under Bid No. B-24-0188 Rebid POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on August 20, 2024, that was attended by the following bidders/suppliers, to wit;

WHEREAS, given to non-complexity of the Goods to be procured, the Technical Working Group (TWG) will conduct a thorough technical evaluation and verification process to assess the Lowest Calculated Bidder's (LCB) qualifications and technical documentation. As mandated under Section 34.8, the TWG is required to complete the post-qualification within 12 calendar days but may be extended up to 45 days for technical evaluations;

WHEREAS, the detailed evaluation of bids conducted on September 6, 2024, resulted in the following;
