"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3252 TO GOLDENS DYNASTY MOTORS, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF KITCHEN FACILITY (BRAND NEW) UNDER BID NO. B-24-0189."
