RESOLUTION NO. B.2024.09.03.02

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-C1473 TO POWER-UP TIRES, BATTERY AND AUTO SUPPLY CORPORATION AS A LOWEST CALCULATED AND RESPONSIVE BIDDER FOR SUPPLY AND DELIVERY OF TIRES UNDER BID NO. B-24-0204."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF TIRES under Bid No. B-24-0204 POSTED in its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on July 24, 2024, that were attended by the following bidders/suppliers, to wit;

WHEREAS, the PHILTYRES CORPORATION submits bid prices in the bid forms, with the amount specified in figures taking precedence over the amount stated in words;

WHEREAS, the Committee agreed that PHILTYRES CORPORATION shall undergo post-qualification by the Technical Working Group for being the lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, during the detailed evaluation of bids conducted on July 31, 2024, the bidder acknowledged a typographical error in the bid prices indicated on their bid forms, and confirmed that the amount specified in the figures should be considered the correct bid price;

WHEREAS, a meeting was held to address the non-responsiveness of PHILTYRES CORPORATION due to inconsistencies between the amounts written in figures and words on their bid forms, with the amount in figures prevailing. However, even considering this discrepancy, their bid still cannot compete with the price submitted by the second-ranked bidder;

WHEREAS, the BAC further agreed that in the event that the bidder with the Lowest Calculated and Responsive Bidder (LCRB) fails, refuses, or is unable to submit the necessary documents as stated in Section 37 of this IRR, the BAC will disqualify said bidder and proceed to complete the post-qualification process with the bidder having the second Lowest Calculated Bid. If no bidder successfully passes the post-qualification stage, the BAC will declare the bidding as a failure and arrange for a re-bidding with re-advertisement. If another bidding failure occurs even after the contract's re-bidding, the Procuring Entity is permitted to engage in a negotiated procurement.

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical and financial requirements, the POWER-UP TIRES, BATTERY AND AUTO SUPPLY CORPORATION has been found to be the Lowest Calculated and Responsive Bidder;

WHEREAS, the detailed evaluation of bids conducted on August 21, 2024, resulted in the following;
