RESOLUTION NO. B-2024.09.17.02

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-1488 TO 3E ELECTRICAL SALES & SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF SINGLE-PHASE ELECTRICAL TRANSMISSION LINE (PHASE II) AND THREE (3) UNITS OF 75KVA DISTRIBUTION TRANSFORMER FOR THREE PHASE LINE UNDER BID NO. B-24-0213."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF SINGLE-PHASE ELECTRICAL TRANSMISSION LINE (PHASE II) AND THREE (3) UNITS OF 75KVA DISTRIBUTION TRANSFORMER FOR THREE PHASE LINE under Bid No. B-24-0213 POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on August 6, 2024, that were attended by the following bidders/suppliers, to wit;

WHEREAS, the Committee agreed that 3E ELECTRICAL SALES & SERVICES shall undergo post-qualification by the Technical Working Group for being the Lowest bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on August 23, 2024, resulted in the following;

WHEREAS, if the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as LCRB and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, as stated in Section 34.4 of the IRR;

WHEREAS, the BAC further agreed that in the event that the bidder with the Lowest Calculated and Responsive Bidder (LCRB) fails, refuses, or is unable to submit the necessary documents as stated in Section 37 of this IRR, the BAC will disqualify said bidder and proceed to complete the post-qualification process with the bidder having the second Lowest Calculated Bid/Highest Rated Bid. If no bidder successfully passes the post-qualification stage, the BAC will declare the bidding as a failure and arrange for a re-bidding with re-advertisement. If another bidding failure occurs even after the contract's rebidding, the Procuring Entity is permitted to engage in a negotiated procurement.

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical, and financial requirements submitted by the bidder as a Lowest Calculated Bid, its bid has been found to be responsive.

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

To recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request a) No. 24-1488 to 3E ELECTRICAL SALES & SERVICES as a Lowest Calculated and Responsive Bidder for the procurement of SUPPLY AND DELIVERY OF SINGLE-PHASE ELECTRICAL TRANSMISSION LINE (PHASE II) AND THREE (3) UNITS OF 75KVA DISTRIBUTION TRANSFORMER FOR THREE PHASE LINE under Bid No. B-24-0213.
