"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3660 TO PRINTCOMP MARKETING AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF LAPTOP (CLERICAL WORK) UNDER BID NO. B-24-0215 REBID."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of SUPPLY AND DELIVERY OF LAPTOP (CLERICAL WORK) under Bid No. B-24**0215 REBID** POSTED on its website, the PHILGEPS, and at a conspicture place within the premises of the Provincial Government of Dayao de Oro continuously for seven (7) calendar days;
