"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-3914 TO TSR FURNITURE SHOP AND MARKETING AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF FURNITURE AND FIXTURES UNDER BID NO. B-24-0230."
