"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-4310 TO GC TECH AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND INSTALLATION OF SOLAR POWERED SPEED LIMIT SENSOR UNDER BID NO. B-24-0275."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of Supply and Installation of Solar Powered Speed Limit Sensor under Bid No. B-24-0275 POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on bidders/suppliers, to wit;
