"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-4953 TO WELD POWERTOOLS AND CONSTRUCTION CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF CYLINDRICAL TANK (VERTICAL TYPE) WITH STAND, STAINLESS STEEL 2,000 LITERS CAPACITY UNDER BID NO. B-24-0277."

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of Supply and Delivery of Cylindrical Tank (Vertical Type) with stand, Stainless Steel 2,000 liters capacity under Bid No. B-24-0277 POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on October 10, 2024, that was attended by the following bidders/suppliers, to wit;

WHEREAS, the Committee agreed that WELD POWERTOOLS AND CONSTRUCTION CORPORATION shall undergo post-qualification by the Technical Working Group for being the Single bidder and to determine whether the bidder complies with and is responsive to all requirements and conditions as specified in the bidding documents;

WHEREAS, the detailed evaluation of bids conducted on October 16, 2024, resulted in the following;
