“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-4534 TO DREAMBUILD CONSTRUCTION, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE 1 LOT- INSTALLATION OF STREETLIGHTS MAPAWA, MARAGUSAN, DAVAO DE ORO [INSTALLATION OF 43 UNITS OF SOLAR STREETLIGHTS] UNDER BID NO. CW24-026.”

WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of 1 LOT- **INSTALLATION OF STREETLIGHTS MAPAWA, MARAGUSAN, DAVAO DE ORO [INSTALLATION OF 43 UNITS OF SOLAR STREETLIGHTS]** under Bid No. **CW24-026** POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on December 10 2024, that was attended by the following bidders/suppliers, to wit;

WHEREAS, given the complexity of Civil Works to be procured, the Technical Working Group (TWG) will conduct a thorough technical evaluation and verification process to assess the Lowest Calculated Bidder's (LCB) qualifications and technical documentation. As mandated under Section 34.8, the TWG is required to complete the post-qualification within 12 calendar days but maybe extended up to 45 days for technical evaluations;



WHEREAS, the detailed evaluation of bids conducted on December 13 2024, resulted in the following;

WHEREAS, if the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as LCRB and recommended to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, as stated in Section 34.4 of the IRR;
