"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 25-0014 TO DREAMBUILD CONSTRUCTION, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE CONSTRUCTION OF ROAD WITH DRAINAGE CANAL AT BRGY. MAGANGIT, NEW BATAAN, DAVAO DE ORO [CONCRETING OF 20 LN.M, CONSTRUCTION OF 670 LN.M CONCRETE LINED CANAL AND 172 LN.M EARTH CANAL] UNDER BID NO. CW25-004."



WHEREAS, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of Construction of Road with Drainage Canal at Brgy. Magangit, New Bataan, Davao de Oro [Concreting of 20 ln.m, Construction of 670 ln.m Concrete Lined Canal and 172 ln.m Earth Canal] under Bid No. CW25-004 POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

WHEREAS, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on January 30, 2025, that was attended by the following bidders/suppliers, to wit;

WHEREAS, given the complexity of Civil Works to be procured, the Technical Working Group (TWG) will conduct a thorough technical evaluation and verification process to assess the Lowest Calculated Bidder's (LCB) qualifications and technical documentation. As mandated under Section 34.8, the TWG is required to complete the post-qualification within 12 calendar days but maybe extended up to 45 days for technical evaluations;

WHEREAS, the detailed evaluation of bids conducted on February 07, 2025, resulted in the following;
