A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) THE ISSUANCE OF A NOTICE OF AWARD TO ABU CONSTRUCTION/DOUBLE J CONSTRUCTION AND SUPPLY (JOINT VENTURE) AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE REHABILITATION OF NEW VISAYAS-BANAGBANAG-MONTEVISTA TO MAGADING, NABUNTURAN ROAD WITH EXPANSION OF EXISTING BRIDGE WITH SUBPROJECT IDENTIFICATION NUMBER CWPRDP-SU-IB-R011-DDO-004-000-000-2023-FMB-R1 LOAN NO. 9577-PH."

WHEREAS, the Provincial Government of Davao de Oro acknowledges the receipt of No Objection Letter (NOL) 2, dated January 30, 2025, issued by the National Project Coordination Office (NPCO) through the Regional Project Coordination Office (RPCO), for the award of the contract for the *Rehabilitation of New Visayas – Banagbanag, Montevista to Magading, Nabunturan Road with Expansion of Existing Bridge* to **ABU CONSTRUCTION / DOUBLE J CONSTRUCTION AND SUPPLY (JOINT VENTURE)**, with a contract amount of *Two Hundred Seventy-Four Million Two Hundred Forty-One Thousand One Hundred Eighty-Two Pesos and 85/100 Centavos (₱274,241,182.85)*.

WHEREAS, after a competitive and transparent bidding process, and following the conduct of post-qualification with the technical assistance of the PRDP personnel, the Bids and Awards Committee (BAC) has recommended the award of the contract to **ABU CONSTRUCTION/DOUBLE J CONSTRUCTION AND SUPPLY (JOINT VENTURE)** for having submitted the Lowest Calculated

and Responsive Bid for the Rehabilitation of New Visayas–Banagbanag, Montevista to Magading, Nabunturan Road, with Expansion of an Existing Bridge;

WHEREAS, upon receipt of the No Objection Letter (NOL) 2, the Bids and Awards Committee (BAC) convened on February 4, 2025, to deliberate on and adopt a resolution recommending to the Head of the Procuring Entity (HOPE) the issuance of the Notice of Award (NOA) to ABU CONSTRUCTION / DOUBLE J CONSTRUCTION AND SUPPLY (Joint Venture), which, upon its issuance and the contractor’s submission of the required performance security within the prescribed period, shall be followed by the signing of the contract, and ultimately, the issuance of the Notice to Proceed (NTP) to formally commence the implementation of the project within the stipulated timeframe.


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE to recommend to the Head of the Procuring Entity (HoPE) the issuance of a Notice of Award to ABU CONSTRUCTION / DOUBLE J CONSTRUCTION AND SUPPLY (JV) as the Lowest Calculated and Responsive Bidder for the Rehabilitation of New Visayas–Banagbanag, Montevista to Magading, Nabunturan Road with Expansion of Existing Bridge, under Subproject ID No. CWPRDP-SU-IB-R011-DDO-004-000-000-2023-FMB-R1, Loan No. 9577-PH.






