**“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 23-4201 JOB ORDER (LABOR & MATERIALS) FOR THE USE OF PROVINCIAL VETERINARY OFFICE AMOUNTING TO ONE MILLION SEVEN HUNDRED EIGHTY EIGHT THOUSAND NINE HUNDRED FORTY PESOS (PHP 1,788,940.00) TO THE ULVAC SINGAPORE PTE LTD PHILIPPINE BRANCH THROUGH DIRECT CONTRACTING PURSUANT TO SECTION 50 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184;”**

**WHEREAS**, the Bids and Awards Committee approved the recommendation of the Technical Working Group (TWG), that the procurement of goods covered by the aforementioned purchase request be done by the way of Direct Contracting pursuant to Section 50 of the 2016 Implementing Rules and Regulations of R.A. 9184;

**WHEREAS**, Section 50 of the 2016 Revised IRR of R.A. 9184 provides further that Direct Contracting may be resorted under any of the following conditions:

- 50 (A) *Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibits others from manufacturing the same item;*
- 50 (B) *When the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of the contract;*
- 50 (C) *Those sold by an exclusive dealer or manufacturer which does not have dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms.*

**WHEREAS**, a canvass was duly conducted to the exclusive supplier and quoted within the approved budget of the contract;

**WHEREFORE**, on motion of Engr. Roderick M. Digamon and was duly seconded by Ms. Lara Zaphire Kristy N. Bermejo; it was,

**NOW THEREFORE**, the Bids and Awards Committee, **RESOLVE** as it is hereby **RESOLVED** to recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request No. 23-4201 Job Order (Labor & Materials) for the use of Provincial Veterinary Office amounting to One Million Seven Hundred Eighty Eight Thousand Nine Hundred Forty Pesos (Php 1,788,940.00) to the ULVAC Singapore PTE LTD Philippine Branch through Direct Contracting pursuant to Section 50 of the Revised Implementing Rules and Regulations of R.A. 9184.
