**RESOLUTION NO. B-2025-03.26.26**

**“A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 25-2076 TO CJEP BUILDERS AND ENGINEERING SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE 1 LOT - CONSTRUCTION OF SINGLE BARREL BOX CULVERT AT DURLAN-LIBAYLIBAY ROAD, MACO, DAVAO DE ORO [CONSTRUCTION OF 3M X 4M X 7.0M BOX CULVERT (CLEAR OPENING), ROAD CONCRETING OF 18 IN.M., INSTALLATION OF 20 IN.M. METAL GUARDRAIL AT B/S AND RIPRAPPING AT 12 UNDER BID NO. CW25-029.”**

**WHEREAS**, the Provincial Government of Davao de Oro advertised the Invitation to Bid for the procurement of **1 LOT - CONSTRUCTION OF SINGLE BARREL BOX CULVERT AT DURLAN-LIBAYLIBAY ROAD, MACO, DAVAO DE ORO [CONSTRUCTION OF 3M X 4M X 7.0M BOX CULVERT (CLEAR OPENING), ROAD CONCRETING OF 18 IN.M., INSTALLATION OF 20 IN.M. METAL GUARDRAIL AT B/S AND RIPRAPPING AT 12** under Bid No. **CW25-029** POSTED on its website, the PHILGEPS, and at a conspicuous place within the premises of the Provincial Government of Davao de Oro continuously for seven (7) calendar days;

**WHEREAS**, the BAC pursuant to Section 30 of R.A. 9184 used the nondiscretionary pass/fail criteria and conducted public bidding on March 24, 2025, that were attended by the following bidders/suppliers, to wit;

WHEREAS, given the complexity of Civil Works to be procured, the Technical Working Group (TWG) will conduct a thorough technical evaluation and verification process to assess the Lowest Calculated Bidder’s (LCB) qualifications and technical documentation. As mandated under Section 34.8, the TWG is required to complete the post-qualification within 12 calendar days but maybe extended up to 45 days for technical evaluations;

WHEREAS, the detailed evaluation of bids conducted on March 25, 2025, resulted in the following;

WHEREAS, if the BAC determines that the bidder with the Lowest Calculated Bid passes all the criteria for post-qualification, it shall declare the said bidder as LCRB and recommended to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower, as stated in Section 34.4 of the IRR;

WHEREAS, the BAC further agreed that in the event that the bidder with the Lowest Calculated and Responsive Bidder (LCRB) fails, refuses, or is unable to submit the necessary documents as stated in Section 37 of this IRR, the BAC will disqualify said bidder and proceed to complete the post-qualification process with the bidder having the second Lowest Calculated Bid. If no bidder successfully passes the post-qualification stage, the BAC will declare the bidding as a failure and arrange for a re-bidding with re-advertisement. If another bidding failure occurs even after the contract's re-bidding, the Procuring Entity is permitted to engage in a negotiated procurement.

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical, and financial requirements submitted by the bidder as a Lowest Calculated Bid, its bid has been found to be responsive.

NOW THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request No. **25-2076** to **CJEP BUILDERS AND ENGINEERING SERVICES** as a Lowest Calculated and Responsive Bidder for the procurement of **1 LOT - CONSTRUCTION OF SINGLE BARREL BOX CULVERT AT DUMLAN-LIBAYLIBAY ROAD, MACO, DAVAO DE ORO [CONSTRUCTION OF 3M X 4M X 7.0M BOX CULVERT (CLEAR OPENING), ROAD CONCRETING OF 18 IN.M., INSTALLATION OF 20 IN.M. METAL GUARDRAIL AT B/S AND RIPRAPPING AT 12** under Bid No. **CW25-029**.
