"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 25-C0405 EXPANDED NEWBORN SCREENING TEST WITH A CONTRACT AMOUNT OF TWO MILLION SIX HUNDRED THIRTY-THREE THOUSAND SEVEN HUNDRED FIFTY PESOS (\$\alpha_2\$,633,750.00) TO NEWBORN SCREENING CENTER-MINDANAO WHO QUOTED WITHIN THE APPROVED BUDGET OF THE CONTRACT FOR THE PROCUREMENT OF GOODS THROUGH NEGOTIATED PROCUREMENT – AGENCY TO AGENCY PURSUANT TO SECTION 53.5 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184."

WHEREAS, the Bids and Awards Committee (BAC) approved the recommendation of the Technical Working Group (TWG) that the procurement of goods covered by the abovementioned purchase request be done by way of Negotiated Procurement – Agency to Agency pursuant to Section 53.5 of the Revised Implementing Rules and Regulations of R.A. 9184;

WHEREAS, Annex "H" of 2016 Revised IRR R.A. 9184 further explains that Agency-to-Agency Agreements shall be governed by the Guidelines unless otherwise provided by a special law;

WHEREAS, procuring goods and services from another government agency is deemed more efficient and cost-effective, thereby providing greater advantages to the government;

WHEREAS, a request for quotation was duly conducted to the recognized supplier and after the opening of the canvass by the Committee, the abovementioned purchase request be awarded to the supplier as acknowledged and recognized by the government to deliver the said goods and services.

WHEREFORE, on motion of Atty. Maria Cor Reyna M. Mutoc and duly seconded by Dr. Rolando S. Simene; it was,



RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request No. 25-C0405 Expanded Newborn Screening Test with a contract amount of Two Million Six Hundred Thirty-Three Thousand Seven Hundred Fifty Pesos (\$\mathbb{P}2,633,750.00)\$ to Newborn Screening Center-Mindanao who quoted within the approved budget of the contract for the procurement of goods through Negotiated Procurement – Agency to Agency pursuant to Section 53.5 of the Revised Implementing Rules and Regulations of R.A. 9184.
