RESOLUTION NO. <u>NP-DRP-11.26.14</u> SERIES OF 2024

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-5335 ONLINE SUBSCRIPTION OF ELECTRONIC LEGAL PUBLICATIONS AMOUNTING TO ONE HUNDRED TWENTY THOUSAND PESOS (*P120,000.00) TO CD TECHNOLOGIES ASIA, INC. WHO OFFERED WITHIN THE APPROVED BUDGET OF THE CONTRACT FOR THE PROCUREMENT OF GOODS THROUGH DIRECT RETAIL PURCHASE OF PETROLEUM FUEL, OIL AND LUBRICANT (POL) PRODUCTS, AIRLINE TICKETS AND ONLINE SUBSCRIPTIONS PURSUANT TO SECTION 53.14 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184;"

WHEREAS, the Bids and Awards Committee (BAC) approved the recommendation of the Technical Working Group (TWG) that the procurement of goods covered by the purchase request be done by way of Direct Retail Purchase of Petroleum Fuel, Oil, and Lubricant (Pol) Products, Airline Tickets And *Online Subscriptions* pursuant to Section 53.14 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, Section 53.14 of the 2016 Revised IRR of Republic Act No. 9184 allows for Direct Retail Purchase of goods and services required by a Procuring Entity for the efficient discharge of its principal mandate, governmental functions, or day-to-day operations;

WHEREAS, the Direct Retail Purchase of the following items may be undertaken by authorized end-users from identified direct suppliers or service providers: (i) petroleum fuel, oil, and lubricant (POL) products; (ii) airline tickets; and (iii) online subscriptions;

WHEREAS, Online Subscriptions shall cover (i) electronic publications, reference materials, and journals; (ii) computer software and applications such as video conferencing applications, computer-aided design and drafting applications, office productivity tools, and system protection software; (iii) web-based services such as news and social media monitoring tools; and (iv) off-the-shelf information systems, except internet and cloud computing services;

WHEREAS, the supplier immediately responded to the request for quotation and signified their technical, legal, and financial capability to supply and deliver the goods to be procured;

WHEREFORE, on motion of Dr. Rolando S. Simene and duly seconded by Engr. Roderick M. Digamon, it was,

NOW THEREFORE, the Bids and Awards Committee, RESOLVE as it is hereby RESOLVED to recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request No. 24-5335 Online Subscription of Electronic Legal Publications amounting to One Hundred Twenty Thousand Pesos (₱120,000.00) to CD Technologies Asia, Inc. who offered within the approved budget of the contract for the procurement of goods through Direct Retail Purchase of Petroleum Fuel, Oil and Lubricant (POL) Products, Airline Tickets, and *Online Subscriptions* pursuant to Section 53.14 of 2016 Revised Implementing Rules And Regulations Of R.A. 9184.
