WHEREAS, the BAC invites technical, legal, and financially capable suppliers to deliver the goods covered by the purchase requests for negotiation and discuss the technical and financial requirements of the goods;

WHEREAS, a request for quotations from the suppliers was obtained, which were opened, evaluated, and verified by the Committee;

WHEREAS, upon careful evaluation and verification, the abovementioned suppliers offered the lowest price quotations.

**WHEREFORE**, on motion of Engr. Roderick M. Digamon and duly seconded by Dr. Rolando S. Simene; it was,

**RESOLVED**, to recommend to the Head of the Procuring Entity (HoPE) to award the abovementioned purchase requests to the corresponding suppliers who offered the lowest calculated and responsive quotation for the procurement of goods through Negotiated Procurement – Two Failed Biddings under Section 53.1 of the Revised Implementing Rules and Regulations of R.A. 9184.
