RESOLUTION NO. NP-TFB-11.20.07 SERIES OF 2024

"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD PURCHASE REQUEST NO. 24-C1555 COMPUTER SUPPLIES/SPARE PARTS AMOUNTING TO FOUR HUNDRED TWENTY-NINE THOUSAND FOUR HUNDRED SEVENTY PESOS (P429,470.00) TO VMO ENTERPRISES WHO OFFERED THE LOWEST CALCULATED AND RESPONSIVE QUOTATION FOR THE PROCUREMENT OG GOODS THROUGH NEGOTIATED PROCUREMENT – TWO FAILED BIDDINGS UNDER SECTION 53.1 OF THE REVISED 'IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184;"

WHEREAS, the abovementioned purchase request underwent two failed biddings due to no bids purchased a bid during its schedule of bid opening;

WHEREAS, the Bids and Awards Committee (BAC) conducted a mandatory review of the terms, conditions specifications, and cost estimates of the abovementioned purchase request as prescribed in Section 35 of the IRR:

WHEREAS, after evaluation of the purchase request, the BAC agreed and recommended that the procurement of goods covered by the abovementioned purchase request be done by way of Negotiated Procurement – Two Failed Biddings under Section 53.1 of the Revised IRR of R.A. 9184;

WHEREAS, the BAC invites technical, legal, and financial capable suppliers to deliver the goods covered by the purchase request for negotiation and discuss the technical and financial requirements of the goods;

WHEREAS, a request for quotations from the suppliers was obtained which were opened, evaluated, and verified by the Committee;

WHEREAS, upon careful evaluation and verification, the supplier offered the lowest price quotation.

WHEREFORE, on motion of Engr. Roderick M. Digamon and duly seconded by Atty. Maria Cor Reyna M. Mutoc; it was,

RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) to award Purchase Request No. 24-C1555 Computer Supplies/Spare Parts amounting to Four Hundred Twenty-Nine Thousand Four Hundred Seventy Pesos (\$\mathbb{P}429,470.00) to VMO Enterprises who offered the lowest calculated and responsive quotation for the procurement of goods through Negotiated Procurement - Two Failed Biddings under Section 53.1 of the Revised Implementing Rules and Regulations of R.A. 9184.
