"A RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) TO AWARD THE PURCHASE REQUEST NO. 23-3139 CLOUD SERVER SUBSCRIPTION AMOUNTING TO FIVE HUNDRED THIRTEEN THOUSAND ONE HUNDRED NINETY PESOS AND 86/100 (PHP 513,190.86) TO THE EPLDT, INC. WHO OFFERED THE LOWEST CALCULATED AND RESPONSIVE QUOTATION THROUGH NEGOTIATED PROCUREMENT – TWO FAILED BIDDINGS PURSUANT TO SECTION 53.1 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184;"

WHEREAS, the aforementioned purchase request was undergone two failed biddings due to no bidder purchase a bid during its schedule of bid opening;

WHEREAS, the Bids and Awards Committee (BAC) conducted a mandatory review of the terms, conditions specifications, and cost estimates of the purchase request as prescribed in Section 35 of the IRR;

WHEREAS, after evaluation of the purchase request, the BAC agreed and recommended that the procurement of goods covered by the aforementioned purchase request be done by the way of Negotiated Procurement – Two Failed Biddings pursuant to Section 53.1 of the Revised IRR of R.A. 9184;

WHEREAS, the BAC invites technical, legal, and financial capable suppliers to deliver the goods covered by the purchase for negotiation and discuss the technical and financial requirements of the goods;

WHEREAS, only price of quotation from EPLDT, Inc. were obtained which was opened, evaluated, and verified by the Committee;

WHEREAS, upon careful evaluation and verification, the EPLDT, Inc. offered within the approved budget of the contract.

WHEREFORE, on motion of Ms. Lara Zaphire Kristy N. Bermejo and duly seconded by Engr. Roderick M. Digamon; it was,

RESOLVED, to recommend to the Head of the Procuring Entity (HoPE) to award purchase request no. 23-3139 Cloud Server Subscription amounting to Five Hundred Thirteen Thousand One Hundred Ninety Pesos and 86/100 (PhP 513,190.86) to EPLDT, Inc. who offered the lowest calculated and responsive quotation through Negotiated Procurement – Two Failed Biddings pursuant to Section 53.1 of the Revised Implementing Rules and Regulations of R.A. 9184.
