**INVITATION FOR MEDICAL, DENTAL AND  
LABORATORY SUPPLIES FOR CONSIGNMENT –  
DDOPH LAAK**

- 1) The **Provincial Government of Davao de Oro**, through **Davao de Oro Provincial Hospital Drug Consignment System (DDOPH-DCS)**, pursuant to Provincial Ordinance No. 118-2024, is inviting interested suppliers/dealers/distributors/manufacturers who intend to become a **Consignor** of Medical, Dental and Laboratory Supplies as required by **DdOPH-Laak** for a duration of one (1) year reckoned from signing of the Contract Agreement with Consignment Request No. **26-0904** under Bid Number **B-26-0006**.
- 2) Delivery of the consigned items shall be required within **Ten (10) calendar days**. The consignors shall submit the required documents, as attached hereto.
- 3) The evaluation and declaration of the winning consignors shall be based on the Lowest Calculated Consignment Offer, as determined through a competitive process. The Provincial Consignment Committee (PCC) shall review the proposals submitted by the suppliers in accordance with applicable rules, guidelines, and consignment procedures. The evaluation of consignment offers and the corresponding resolution or recommendation of the PCC shall thereafter be submitted to the Provincial Governor for approval.
- 4) Interested consignors may obtain further information from the address given below, from **Monday to Friday, 8:00 a.m. to 5:00 p.m.**
- 5) A complete set of Consignment Documents may be acquired by interested Consignors on **February 9, 2026** from the address given below. It may also be downloaded free of charge from the website of the Procuring Entity.
- 6) Consignment Offers must be duly received by the Provincial Consignment Committee Secretariat through manual submission at the Provincial Economic Enterprises Management Office (PEEMO), 2<sup>nd</sup> Floor, Right Wing, Provincial Capitol, Cabidanan, Nabunturan, Davao de Oro Province on or before **February 19, 2026 until 8:30 a.m.** Late Consignment Offers shall not be accepted.
- 7) Opening of Consignment Offers shall be on **February 19, 2026, 9:30 a.m. onwards** at **Conference Room 2, 4<sup>th</sup> Floor, Executive Building, Provincial Capitol, Cabidanan, Nabunturan, Davao de Oro Province**. Consignment Offers will be opened in the presence of the Consignors' representatives who choose to attend the activity.
